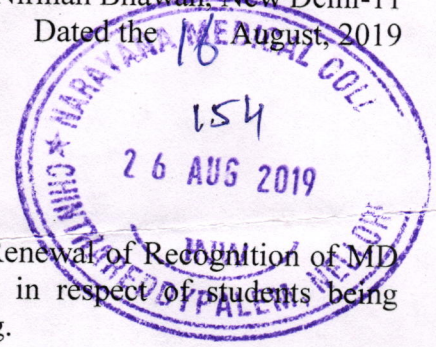


Sir/Madam,
