- (3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
- (4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

In view of above, you are requested to issue necessary notification at the earliest recognizing Narayana Medical College, Nellore for the award of MBBS degree when granted on or after February, 2019 by Dr. NTR University of Health Sciences, Vijayawada against the increased intake i.e. from 150 to 250 seats.
