Management Information System (MIS) gathers data from multiple online systems, analyzes the information, and reports data to aid in management decision making. MIS is increasingly being used for information storage, handling, processing and retrieval of data for improving the services provided by organizations. It allows quick decision making for overall functional improvement. Creates a Common and Continuous Communication and Data Sharing Platform among Stakeholders. Due to the online attendance system, parents receive communication immediately when the ward is not attending a class/ lecture. The administrators and teachers in a transparent way can visualize the attendance and are able to identify the absentees immediately for necessary action. Minimizes the Administrative and Communication Costs: There is a significant reduction in the communication costs annually after MIS automation as well. The information and requirements are ordered online and the sanctions and delivery of equipment, drugs and other consumable and nonconsumable items are available online. This has facilitated the communication channels and eliminated the delays. Utilization of Resources and Time to the Optimum: Through the existing Systematic approach of MIS the college is able to demonstrate optimum use of time, and resources and a significant reduction in costs incurred. Narayana Medical College is a highly Complex organization with multispeciality and super speciality hospitals on one side and the medical students, and faculty on the other. The attendance workflows and monitoring of staff is an immense task requiring greater surveillance and management. Retrieval of real-time student attendance data for desired/mandatory purposes is very difficult. Hence, NMC has developed an in house MIS software module for the automation of attendance management. It consists of an integration of Departments on a common platform with individual dashboards and login credentials for Administrators, students, faculty and parents. This facility could provide efficient administrative control and management course wise, Department wise, Class wise. Timetables, faculty allocation and foolproof online student attendance recording reporting. There is also a provision for multiple autogenerated

attendance reports - Periodic, Phase wise/ Class wise and overall Reports - Attendance and Absence report in detailed and matrix format. There is an inbuilt individual and cumulative attendance calculation formula for real-time reporting. This has completely eliminated paperwork and manual effort. After this MIS online attendance management system was installed, Narayana Medical College hospital was able to handle the attendance management process of its staff and students in an efficacious way. Furthermore, a humongous amount of money spent annually on stationery and printing was cut down significantly. Finally, the MIS is able to achieve enhanced Decision making with powerful analytics.

15.Multidisciplinary / interdisciplinary

The teaching and training of medical students at this institute is mainly based of multidisciplinary and transdisciplinary based. Clinical medicine is taught by a group of health care personnel trying to inculcate the cohesive team based healthcare practice. Clinicians along with the health educators, psychologists and peripheral health care personnel participate in the case discussions.

The organisation of multidisciplinary seminars for the students, common academic program highlighting the transdisciplinary web of health, participation in the Implementation of national health programs, Common clinic-pathological conferences, mortality meets, celebration and organisation of national health days are examples of interdisciplinary teaching and training in medical education at Narayana Medical College.

The central research laboratory serves as the control point for various research activities jointly conducted by the departments. The facilities maintained by the core research team ensure the full participation of interdisciplinary staff in common research activities.

The Hospital management system accessible to all the departments is able to create a virtual link between all the departments. Medical students freely exchange their thoughts and ideas te with the students of Pharmacy, Physiotherapy, Laboratory and Allied Health Sciences and Nursing disciplines.

16.Academic bank of credits (ABC):

The academic credits gained by the medical students through successful completion of the value-added courses and Enrichment courses are deposited at the Academic Bank Account of the student and the validity of such credits shall be as per norms and guidelines. The ABC do not directly accept any credits from the students. The credits offering institution transmits the awarded credits to ABC.

Students who are provided with unique ID and access can open the ABC individual Academic Bank Account in digital form confirming to the Standard Operating Procedure. Medical students who also opt the research methodology course from NAPTEL can also access their successful course completion certificate through ABC.

Though the Medical Colleges are not having the credit-based assessment system, students are offered credit-based courses in the form of value added or enrichment courses. Students feel and experience the flexibility of accessing the credit-based certificates from anywhere.

17.Skill development:

Clinical skill development and acquiring proficiency is one of the key factors in medical education. Skill Laboratory designed as per the accreditation standards is actively engaged in providing adequate training in certifiable skills development among undergraduate and postgraduate students. Short training programs for basic and clinical science students is a regular feature at Clinical Skills laboratory.

Realising the number of challenges that arise from physical patient involvement in training medical graduates, standardised patients and simulation models are introduced. Students are subjected to repeated skill performance on simulation models till they acquire proficiency. Healthy volunteers are carefully coached to simulate an actual patient, such that the simulation would not be detectable by a skilled clinician. As consistency is important in testing and assessing the skill proficiency among students, standardised patients are the norm in formative assessments. Sometimes, Virtual patients in online tools are also being used in clinical skills assessment. Faculty are inclined to blended approaches with patient resources such as combining a virtual patient clinical history with physical laboratory and investigations records. for example, the student might read a patient's history and clinical examination findings and then augment his or her learning afterward with physical X-rays, Ultrasound images, CT scans and other investigations.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Students are exposed to Indian system of medicine (AYUSH) through frequent visits to the AYUSH centre, arranging lectures by the AYUSH specialists and onsite training in the field. Students are instructed to gather the health care information in the village detailing the use of home remedies and the Indian system of medicine.

Immediately after admission, students are taught important landmarks in the healthcare scenario in India. Lectures explaining the advantages and disadvantages of AYUSH and people preferences and beliefs in these systems are incorporated into the curriculum. Practically, students experience the history of medicine during the second year of their MBBS course. Again, during the internship period, two weeks of clinical posting at one of the AYSH centres is also a mandatory feature.

Students are encouraged to undertake to participate in the weekly Yoga course conducted by the institute. There is no fee charged for this course and is open to all the students. These weekly sessions are accommodated in the regular teaching schedule.

The institute is also engaged in research in collaboration with the Siddha Institute on COVID-19. Students participate in the research activities involving the use of medicinal plants & herbs in common diseases as a part of their curriculum in Pharmacology.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

Since, 2019, students are being trained in outcome based (competency based) medical education. The outcomes are identified as certifiable skills comprising of knowledge, attitude and psychomotor skills. In each subject, students are promoted only after ensuring their successful achievement of the certifiable skills.

The traditional educational frameworks and methods are reframed and teaching and training methods suitable for outcome based medical education are introduced. The student centred, individual paced, skill targeted approaches where curriculum is driven by competencies are being used. The learning outcomes are closed integrated with the institute's vision and mission. It is expected that students at the time of graduation (summative examination), shall be Knowledgeable, combined with specified competence and attitudinal professionalism.

20.Distance education/online education:

The online assessments introduced during 2019 are limited to

multiple choice questions. Later on, short answer questions and essay questions are also incorporated in the formative online assessment. The COVID-19 pandemic forced the faculty to switch to online teaching. After initial hiccups, the online teaching was extended for clinics. The two years of online teaching and online assessments converted the present teaching and training into a hybrid mode.

Students are taught in the physical classroom and the coursework are as online assignments. The hybrid mode of teaching is limited to the enrichment and value-added courses. There are a couple of hybrid courses in resident as medical teacher and epidemiology for clinicians. These courses are assessed online for certification.

As such, Dr NTR University of Health Sciences handles the designing and development of curriculum for all its Under Graduate and Post Graduate Courses based on the regulations of regulatory body viz; National Medical Commission, New Delhi. Annual Academic Calendar,			

Time tables, schedule of internal examinations are planned well inadvance. Academic calendar and curriculum are displayed on notice boards and also in the college web-site for the information of all its stakeholders.

Whenever new syllabus is introduced, Medical Education Department and curriculum Committee discusses with the respective heads of the departments. Recommendations and suggestions of individual departments are discussed at college level and forwarded to affiliating university to incorporate the same in the prescribed syllabus. The Institute has put in place extensive infrastructure for technology driven teaching and learning. College focus mainly on student centric learning methods, experiential learning. Mentors continuously interact with mentees to assess their performance and provide assistance to tackle their problems that are encountered during their learning process. The evaluation and assessments of the students aim at measuring course outcomes as against the defined course objectives.

College organizes Medical camps and Health Awareness walks every year in order to create awareness of general health among rural public, students and employees of the organization by providing general health care services and counselling on basic health care and hygiene. Moreover, as a part of community service, college organizes blood donation camps to motivate students and employees to donate blood.

Consistent poor performers are identified as slow learners and additional coaching where ever required is arranged. The Narayana medical college is keen on monitoring the performance of the students and reports of performance and attendance of the students are regularly sent to the Parents. The parent teacher's committee is formed at the beginning of every academic year and meetings will be organized regularly for both the regular and supplementary batch students. Feedbacks will be received from the parents through Parent-teacher meetings and from students periodically at the department for implementation of the necessary remedial action and the feedback taken was anonymous as it improves the transparency.

The slow learners were picked out after the First internal examination marks were released. The students who scored less than 40% were categorized as slow learners. The parents of the slow learners are called to discuss the remedial measures in order to facilitate the student's progress. The students were given freedom to express their problems and issues personally. Students who require professional counselling were sent for sessions. Slow learners are offered with Extra Classes and periodical weekly assessments. The institute has Mentor - Mentee system and mentoring faculty are identified and assigned as mentors for all the students at the beginning of each academic session.

Clinical training facilities at Narayana Medical College facilitate problem-based as well as casebased learning in addition to effective patient care. Radiology department equipped with Digital radiography, 128 slice CT scan, Three Tesla MRI facilitates. 25 operating theatres including the modular theatres and other advanced equipment for student learning like Lasers, advanced surgical equipment. Central Sterile Supply Department ensures a quality assured environment in the clinics. Community-based Medical education offers a range of positive learning experiences for students while providing required medical services for the underserved. The college has fully equipped Rural Health Training Centre and three adopted Primary Health Centers to provide screening and treatment needs of the rural population. The campus has well equipped skill labs with CPR, Automated External Defibrillator and other advanced mannequins. The institute has a solar energy plant installed on all the buildings and connected to APSPDCL Grid. The generator facility is available as a backup. The Campus houses well ventilated spacious hostels for boys and girls and also international Students. All the students and staff are provided with primary medical care at the Institute Hospital. The campus is safe and secured under 24 hours CCTV surveillance with well-trained security staff. Fire extinguishers are installed.

A total of 25 Operation Theatres are available. Central Sterile Service Department is available to serve the sterile material. Medical, Surgical, Pediatric, Neonatal, Respiratory & Coronary care ICUs are well equipped with monitors, ventilators, defibrillators, central oxygen, suction, IABP and facility for dialysis inside ICU.The dialysis unit functions round the clock. Pharmacy is open round the clock. Hospital is well equipped with CT and MRI machines, Digital Subtraction Angiography lab, Mammography & Sono-mammography machines, Cath Lab, Neuro EEG lab. Apart from Interventional radiological procedures some special procedures are carotid artery stenting, cerebral sinus thrombolysis, aneurysm clipping, cerebral & peripheral DSAs, CT guided biopsies. Postgraduate students assist in procedures & get trained under supervision. Fully equipped labs with 24 hours services like Flow cytometry, Chemiluminescence, Dry chemistry analyzer and BacT/Alert 3D 60 for blood culture.NABB accredited blood bank offers services like therapeutic Plasma Exchange, Platelet pheresis.Clinical Skill and Simulation Labs are equipped with mannequins & simulators.

OPAC (Online Public Access Catalogue) which can be used by all the students and teaching faculty for search of books by title/ author name etc. The Library has been accommodated on three floors. The whole building is around 4200 sq. mtrs. The Books are classified according to Dewey decimal classification. The books are being barcoded, and the face recognition devices are placed at the Library entrance to control access only authorized users and to track the members' attendance. There is a separate E-Library section for erecourses and subscribed to DELNET and NTRMEDNET Consortium & Digital Library.

There are incidences where, few senior faculty have donated their rare books to our college library for a greater cause.We have specific digital library for collection of books that are having limited or noavailability in India. We also encourage each departmenthave specific digital library forbooks including rare volumes. There is constant effort from library committee and managementto procure these rare volumes of books, journals and manuscripts both in digital and hard copies.We are attaching an annexure of rare books in our library. The infrastructure is well maintained by implementing and following Standard Operating Procedures (SOPs). There is dedicated Maintenance Department with expert staff for each section. Regular scheduling of work with log books ensures optimum usage of facilities. The Head -Maintenance oversees the maintenance and utilization of facilities. The Head - maintenance has primary responsibility in planning, purchasing, condemning and controlling the use of physical resources under the guidance of the CEO of the institution and also conducts periodic checks to ensure the efficiency / working condition of the infrastructure. Optimum working condition of all medical equipment in the campus is ensured through annual maintenance contracts (AMC), which is signed with the authorized agencies/manufacturer only. Maintenance labels are placed on equipment, such as date of service & due date of next service. Every department maintains a stock register and log book for the available equipment. Proper inspection is done and verification of stock takes place at the end of every year. All medical equipment are taken care by Bio medical engineers. Periodic reporting on requirements of repairs and maintenance are submitted by the HODs to the CEO of Institution. System for proactive planning is in place with Head of the Maintenance Unit.

The institution has initiated several steps to boost the research output of the institution. During the year 2021-22, training programs of research paper writing, mandatory enrolling of all postgraduates in research methodology course, promoting publication of research findings in journals indexed in databases like Scopus, Pubmed, Web of Science and Embase. These measures are able to yield satisfactory results.

During the reporting year, 42 papers are published by the faculty and postgraduate students. In order to encourage the undergraduate students and motivate them to undertake research, state level ideathon competition has been organised. In this ideathon, 35 participants presented their innovative ideas. A panel of judges selected the best three ideas suitable for further exploration are identified. 8.1.2 - Students are exposed to quality of care and patient safety procedures including infection prevention and control practices as practiced by the teaching hospital in didactic and practical sessions during their clinical postings.

The students of Narayana Medical College are trained in the key indicators of Medical care in term of recovery; restoration and survival are stressed during didactic lectures and practical sessions. They are also sensitized about importance of first aid, universal precautions to be followed before and after certain procedures, importance of Immunization in children and adults, Basic Life Support (BLS), Advanced Cardiac Life Support (ACLS) training, and Bio-medical waste disposal etc. Undergraduates are exposed to the safety procedures such as hand washing, autoclaving of instruments, operation theatre fumigation, health care associated infections and its prevention. Students taught about importance of hospital/bio-waste management (BMW) starting from segregation and disposal of these wastes. In Clinical postings students are taught about patient management during relevant case discussions and hospital rounds. Skill labs provide an excellent environment for the students for training. While practicing in Skill lab using different models, manikins, video clippings, students get the opportunity to learn from their mistakes. Institution also provides links to department wise power point presentations on important topics, video clippings on safety procedures that are accessible to students on college website.

Narayana Medical College & Hospital is one among few institutions that is recognized and approved as transplant Hospital. The institution has taken several positive initiatives to advocate medico legal, ethical and social issues of organ donation and transplantation. Department of Nephrology regularly conducts World Kidney Day with agenda to increase the awareness about kidney disease in the general population and to prevent increase in the incidence of kidney problems in the community. It also aimed at promoting cadaver kidney transplantation in the society to meet the demand for various organs in the needy population. The lecture sessions also addresses on the importance of kidney donation, legal and ethical issues. Rallies were also conducted to improve the awareness on organ donation awareness in public. Students of Superspecialties, PGs and Interns are involved in these programs. Department of Anatomy enlightens the I MBBS students about the cadaver donation at the beginning in the lecture sessions and interactive sessions. Institution encourages the students to involve themselves in such types of activity, thereby improving and equipping themselves with medico legal, social and ethical issues and also their social responsibility towards Transplantation of Human Organs.

UG students training

Students are made to observe the vaccine administration, shown vaccine vial monitor and explained how to read the monitor, taught about the adverse events following immunization and their management.

Students are given chance to give oral vaccines like oral polio, rotavirus vaccine etc.

Students are shown how to reconstitute the vaccines and load them, how to clean the area of injection site and how to identify the correct area of body to give vaccines.

Students are shown the immunization cards given to the mother and shown how to enter the date of vaccination and how to calculate the date to be given for next immunization session.

PG students training

PG students will conduct the immunization sessions under the supervision of a faculty member

PG students maintain the vaccination records which Contain date of vaccination name and address of the child and the vaccines received

by the child

PG students enter the vaccination details in the immunization card given to the parents.

They also calculate and enter the date of next vaccination session

When any adverse events occur following vaccination, PG students will treat the child and inform the staff accordingly.

Narayana Medical College evolved its own institutional goals to prepare a highly qualified and skilled medical Graduates Competent to practice preventive, curative, palliative and rehabilitative medicine in respect to the commonly encountered health problems. The UG and PG programs offered in this institute have well-defined learning outcomes and competencies to be attained by the learners to meet the program outcomes (PO) as recommended by the Regulatory bodies. Course outcomes (CO) are defined considering the hierarchy of learning. Faculty members prepare the lesson plans with explicit Specific Learning Outcomes (SLOS), which are mapped with course outcomes. SLOs are discussed with the students in each class and the outcomes achieved are assessed through formative assessments. The psychomotor domain is assessed through direct observations, using OSCEs and OSPEs and through logbooks and direct observations at practical and clinical settings. At the end of the each course, students achieve academic excellence, develop critical thinking, prepare him/her for working as a team, follow ethics and develop leadership quality evolving into a committed and focused medical professional. The institute has developed an exclusive module to train the healthcare professionals during the induction program to inculcate professional and ethical behaviours among the learners.

8.1.11 - Steps/procedures adopted by the College to expose students to contemporary medico-legal practices and third-party payers/insurance mechanisms, indemnity insurance protection etc. relevant to the clinician/provider as well as the patient/recipient.

At Narayana Medical College, Knowledge about contemporary medico legal practices is instilled into II MBBS students during theory and practical hours. Reason for obtaining consent in medical practice, rules to be followed while getting informed consent, importance of documentation related to medico-legal cases and gaps in documentation, unethical and unprofessional behaviour involved in medical practice and laws related to these practices are taught in theory as well as block posting sessions by department of Forensic Medicine and Community Medicine respectively. During internship, Importance of issuing of Medico-legal certificates is highlighted during the orientation course as well as in casualty postings. They are also educated about record keeping and retrieving. The students thought about the medico-legal aspects through continuous medical education (CME) programs on topics like Legal intricacies of medical practice, consent in medical practice, combat against medical negligence, Issuing Death certificate, Role of doctor in casualty etc. In addition, College also organises special lecture sessions by Legal Professionals on Legal awareness in Medical Profession, which stress on importance of medical ethics, CPA, indemnity insurance, care while issuing death certificate etc.
